July 7	Work being shipped must arrive by this date and no earlier than June 30
July 13	Exhibit Reception Thursday 5:00pm-7:00pm Reception Awards ceremony 6:00pm
August 14	Pick up day 9:00am-4:00pm

**Awards:** Cash awards for Best of Show, first and second place in each category and Best American Landscape.

**Categories include:** Oil/Acrylic; Pastel Painting; Watermedia; Printmaking; Mixed Media; Drawing; Fine Art Photography and Sculpture. No Crafts.

### RULES:

All works must be for sale at the fair market value. Please submit only work that will be available at the time of the exhibit and will remain for its entirety. Living artists only. Work that is copied or done under the guidance of an instructor is not eligible. Entries must not have been previously exhibited at CCAA. If the work does not fully reflect what is represented on the jpeg the Cape Cod Art Association reserves the right to eliminate it from the exhibition.

### SIZE REQUIREMENT

**Paintings may not exceed 45" in any direction, including frame.**

### FRAMING

Paintings must be fitted firmly in frame with wire for hanging. No loose glass over mats. Poorly presented work will not be hung.

### JURORS

Beverly Carreiro, Carolyn Letvin and Amber Turlentes. See our website for bio information. There is no personal feedback given by jurors.

### NOTIFICATION

**Notification will be done by email regardless of outcome. If you do not receive your notification by June 12th contact us.** Please check your junk mail in your email account.

## COMMISSION

CCAA charges a commission of 40% on Non-member sales in our gallery. Members are charged 30% commission.

## ENTRY FEE

\$25.00 per piece/non-member

\$20.00 per piece/member Members must enter **CCAA** in Discount Code box then click apply.

*Membership status will be verified.*

Five (5) entries per artist may be submitted. The jury may accept a maximum of two works from any one artist. Payment is non-refundable and does not guarantee acceptance.

## JPEG SIZING

The image size must be in JPEG format, at 72 dpi and less than 4 MB.

## ENTRY BY WEBSITE UPLOAD ONLY

Visit <https://client.smarterentry.com/capecodart> to enter online. **It is strongly recommended that you do not use Internet Explorer, instead use FireFox or Google Chrome.** If you are new to Smarter Entry you must first register as a *First Time User*. If you have used Smarter Entry in the past you must log in as a *Returning User* at the bottom of the page. After log in, choose *The National 2017*, then follow the steps for payment and upload.

## ARTWORK DELIVERY

Shipping, return shipping and a handling fee are the responsibility of the artist. Delivery instructions will accompany email notification of acceptance. Purchase of return shipping labels are the responsibility of the artist. **SELECTED ART WORK MUST ARRIVE BY SCHEDULED RECEIVING DATE AND MUST BE PICKED UP ON SCHEDULED PICK UP DAY.** (See Calendar)

## REGULATIONS

*By entering through Smarter Entry the artist agrees to the following:*

I understand that each entry is partially covered by insurance in case of fire, theft, or vandalism while in the Cape Cod Art Association building. The Officers, Board of Directors and employees will use care in handling art work, but in no way are responsible for any damage that may occur in uncrating, moving or hanging art work. CCAA reserves the right to reject any work which cannot be displayed in a safe and secure manner, (including poorly framed or wired work) or which does not fully reflect that which is portrayed on the jpeg. Accepted pieces will be part of an online gallery on our website. Pieces will be listed for sale using the JPEG submitted. I understand that the CCAA receives a commission on all sales.
